## **ABOUT SKIP**

Skills for Progress (SKIP) is an all India Association of Private Technical / Vocational Training Schools. SKIP was founded in 1968 and registered in 1969, in Bangalore under the Mysore Societies Registration Act. SKIP's membership consists of charitable Vocational Training Institutes who are registered under the nonprofit sector and are conducting a range of technical and non-technical training programs in formal and non-formal trades for the employment in the manufacturing & service sector and self-employment.

There are currently 200 plus members spread across the country.

SKIP capacitates its members through training programme, learning events like project and workshops etc. Each year, over 40,000 trainees pass out of SKIP

member Institutions and more than half of them are from rural areas, trained in about 50 skills in the member institutions. About 15 percent of them are young girls and women trained for income generating activities and employment.

For effectiveness of the network, members are clustered into 8 different Regions according to the geographical locations and convenience. Currently these regions are well spread across the Country. Members in the Regions mutually support and collaborate with each other for mutual learning and sharing.

SKIP's members are located all over India, and one in Nepal. SKIP has the following 8 geographical Regions and each Region is managed by an Honorary Regional Secretary.


opportunities from various Corporates.

# **Programmes for the Year 2014-2015**

#### **Scholarship Programme**

The SKIP Scholarship programme has been in existence for more than four decades. For the past 9 years, the scholarship programme has been fully self-supported from SKIP House rentals collected.

The budget for the Scholarship Grant Program was Rs.15 lacs for the year 2014-15. A total of only 107 Scholarship applications were received out of 170 eligible SKIP members from 8 regions.

A total of 107 institutes were granted scholarships amounting to Rs.19,17,125.00 for 2014-15.

# M/s. Deutsch-Indisches Kinderhilfwerk (DIK), Germany – Short Term Skill Training Project:

This project titled "Occupational Skill Training for School Dropout girls and young unemployed women from the tribal and the neglected community" successfully completed the first year's project, training a total of 600 beneficiaries of which 507 were young girls and unemployed women and 93 boys on 9 different trades. A total of Rs.32,03,000.00 with Rs.7,50,000.00 for EDP was disbursed under the project, during the first year 2014.

This Short Term Skill Training project generated much better results this year, as compared to past training due to its systematic implementation, which was well monitored in 3 different phases and was also appreciated by the members of the SKIP Board of Governance and the community at large.

The project had no age barriers and restrictions or social discriminations as the project had planned to provide skills for livelihood for the target beneficiaries.

As a part of the final phase of the project, Mr. Joseph Stanley General Secretary along with SKIP Board of Directors the Regional Secretaries carried out the evaluation process on the trainees placements for employment and selecting 100 girl trainees for EDP / self-employment support. They interacted with trainees and management. The overall outcome was satisfactory as all of them implemented the project as per the project expected lines.

# **DIK - Entrepreneurship Development Program (EDP):**

As per the proposed project plan, among the 600 youth who successfully completed the short term skill training program, 100 girls were selected for Self-Employment / Enterprise Development support.

As proposed, QUEST successfully conducted 4 workshops of 3 days each, Train the Trainers (ToT) program for SKIP member institutions in "Life Skills and Work Skills". About 16



member Institutes have already been using QUEST's resource materials in their Institute.

- Western and Northern Regions from 25th to 27th September 2014 at Goa.
- South Central, South East and South West Regions from 6th to 8th November 2014 at Bangalore
- North East, Central and Eastern Regions from 27th to 29th November 2014 at Kolkata



Review of the workshops was held at SKIP Office in December 2014. M/s. Quest was satisfied with the outcome. Workshops and programs were planned for 2015 to cover all regions.

QUEST Alliance has supported SKIP members for the 4 Training workshops, boarding and lodging expenses for all the participants. SKIP is grateful to QUEST Alliance for this financial support and for their valuable partnership in SKIP's skills mission by adding value to the employability skills of the trainees. About 16 SKIP member institutions are using their workbook contents.

## **SKIP Advanced Tech Centre**

The SIEMENS supported CNC Training Centre was inaugurated on 6th December 2013, in view of the emerging demand, for skills in automation and motion control technology. Realizing the need for advanced technological training for member's institutes, SKIP established the Advanced Tech Centre. This Advanced Tech Centre provides a basic spectrum of motion control technology for the trainees from SKIP Member Institutes in CNC and PLC concepts.

Globally CNC operators and programmers are in big demand with good remunerations. SKIP members can prepare ITI trainees to make use of this opportunity. During lean period the CNC and PLC training is opened to others and the Industry.


A joint review was conducted by SIEMENS and SKIP on 23rd December 2014. The team took note of the good achievements in terms of total number of trainees trained in CNC training which was remarkable. 80% of the trainees have been from SKIP member Institutions from across the country for the under privilege at a very basic cost for which is SKIP has provided subsidies. For Non-SKIP members and others, the fee structure has been in par with the market fee structure.

Impact of the training is observed from the number of booking done by the Institutes which is overwhelming. Trainee's interest is seen through daily attendance, enthusiasm and eagerness to learn the programming skills, completing the assignments on time, etc.

PLC will commence shortly as the last phase of assembly and interfacing is being is carried out.

The demand for the CNC training at the advanced tech centre is increasing from SKIP member Institutes due to subsidised fee structure for SKIP members only. SKIP is meeting its objectives through this training program by adding value to the trainees skills in getting better job opportunities.

SKIP acknowledges its appreciation to the SKIP Advance Tech Centre Team for its dedicated services.

'I am student of St. Lawrence ITI, Nagarkoil. I came to know about SKIP Advance Tech Centre and they are conducting CNC Training in operation and programming.' I thought if I do this program it would enhance

my job opportunities and hence I took up this training and got trained in 828D SIEMENS control in operation and programming (Turning).

After completing this training program I was very confident in working in an Industry as this training gave me courage and confidence to work in an industrial environment. By God's grace I got a decent job in Bharat Petroleum Corporation Ltd, Cochin. I feel my certification from SKIP Advanced Training Centre in CNC programming gave me the advantage for my selection. I now get a salary of Rs. 14,000/-. I am very happy I did this CNC programming as, it has enhanced my job prospectus in the Industry.

# SKIP Advance Tech Centre - infrastructure development at Kengeri Bangalore

In view of the activities to be conducted at the SKIP Advance Tech Centre, CNC is gaining momentum. PLC is yet to start. Renewable Energy training is planned along with Karnataka Power Transmission Corporation ltd.

The 5 class rooms measuring 92'x20'=1840 sq. ft. is constructed at a cost of Rupees 6 Lakhs. Training activities are being planned for the local girls around the area. The Provincial of the Ursuline Sister's at Mysore will depute a Sister to oversee the training program since, it is for girls.

We are still exploring the funding sources and only 24 SKIP members have made their contributions to a total of Rs.1,40,000 towards the development of Kengeri Land. The Governing Body of SKIP is making efforts to

explore the various sources of funds. It will also try to source funds from past donors and philanthropist, corporate houses under their CSR budget etc. SKIP is processing 35 AC applications from the Income Tax Department for tax exemptions from donors.

# From the Women's Representative

SKIP has taken numerous efforts in the empowerment and upliftment of underprivileged young girls and women. Out of 200 SKIP member institutions 35 are exclusively for only girls and women, managed by women. There are about 120 co-eds. Every year about 6000 girls and women are trained in SKIP institutions.

On 29th May 2014, an exclusive workshop for women's institution was held at Ashirbhavan, Kerala on "Promoting CSR for Skills Training and Sustainability".

The DIK project on short term skill training supported 500 girls for employment and 100 for self-employment.

Improved change in skill trends for girls was observed, which was a break through while 5 girls opted for 4 wheeler driving course and 4 on Industrial Security Guards which was quite uncommon among the tribal girls.



SKIP is exploring ways to support the underprivileged girls and Women, and improve the quality of training by Women's Institutions and possibilities of offering training in new areas which has market potential like Hospitality, Retail, Health Care, Fashion Designing, Beautician, Food Processing etc.


### **Eastern Region:**



The WORTH Trust had its beginning as a Rehabilitation Centre set up by the Swedish Red Cross in 1963 for the rehabilitation of the leprosy-cured persons through training in light engineering activities, which marked a paradigm shift from the beaten track of rehabilitating them in the traditional activities such as weaving, candle-making and agriculture-based activities.

The 50 years that have gone by since the starting of the WORTH (Workshop for the Rehabilitation and Training of the Handicapped) Trust in Katpadi speak about the story of the training and rehabilitation of the differently-abled and the development of a self-sustaining model in the task of rehabilitation.

The Swedish Red Cross Rehabilitation Industries metamorphosed into the present WORTH Trust,

accomplishing various goals including the training of the differently-abled, especially the leprosy-cured and the polio-afflicted youth and their rehabilitation in industries started by the Trust itself not only in Katpadi, but also in Tiruchi, Paranur (Kancheepuram district) and Puducherry.

### **The Leprosy Mission India**

We are happy to share the good news of The Leprosy Mission India receiving the "Times of India Social Impact Award 2015". From over 1100 applicants for the Social Impact Award, TLMTI bagged the NGO award in Health category. They are SKIP members since 1994, and we are proud to be associated with them.

The Leprosy Mission Trust India (TLMTI) is the largest Non-Governmental Organization (NGO) in India working with and for people affected by leprosy over 140 years of its existence.
